

## Free Meal Announcement-2020-21

We just learned today that Immaculate Conception School qualifies for Free Breakfast and FREE Lunch for all of our students. This new procedure became effective Oct. 1<sup>st</sup> 2020. These are the guidelines that we will be following in regards to this new program:

- If your child(ren) ate lunch and or breakfast the month of Sept. you will be billed for those meals like we have always done previously.
- October 1<sup>st</sup> was the beginning date for the Free Lunch and Free Breakfast Programs for Public Schools.
- Immaculate Conception School received approval on Oct. 6<sup>th</sup> for our school to participate in the Free Breakfast and Free Lunch Program.
- Starting Wednesday Oct. 7<sup>th</sup> All students are invited to eat Breakfast and or Lunch at **no cost** to our families. YIPPEE SKIPPEE. Breakfast will be served at 8:00am. If your child wants to eat breakfast and it is 7:55am-8:00am the students can go directly to the gym area and line up for breakfast. **Mrs. Hurt and Mr. Young will be there to assist students. The students will be escorted to their classrooms after eating breakfast.**
- FREE is one tray of food For Breakfast and Lunch ( a single serving of each item offered) that includes one milk for lunch one milk for breakfast.

**WHAT IS NOT FREE; When students want a second, or third carton of milk. The cost for a second milk is .45cents. When students take a second helping of an entrée. The cost for a second helping of an entrée is \$1.50. Families will be billed for these items.**
